Mobile App Privacy Policy

The Confederated Salish & Kootenai Tribes built the Confederated Salish & Kootenai app as a free app. They provide it at no cost and are intended for use as is.

The purpose of this privacy policy is to disclose why the app collects and uses personal information during its usage. If you choose to use the app, then you agree to the collection and use of information within this policy.

Information Collection and Use

For a better experience, the app requires you to provide it with certain personally identifiable information, including but not limited to email and name. Also, it retains the requested information and uses it as described in this privacy policy.

The app does use third-party services that may collect information used to identify you. The following are links to the privacy policies of those services used by the app:

Log Data

In a case of an error within the app, the app collects data and information (through third-party products) on your phone called log data. This log data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the app's configuration when utilizing it, the time and date when you used the app, and other statistics.

Cookies

Cookies are files with a small amount of anonymous data used as unique identifiers. The app does not use them explicitly. However, the app may use third-party code and libraries that use cookies to collect information and improve their services. However, cookies are disclosed, are optional, and you can accept or refuse them. With that said, if you choose to refuse cookies, certain portions of the app will be unusable.

Service Providers

We may employ third-party companies and individuals due to the following reasons:

- To provide the app on behalf of the Confederated Salish & Kootenai Tribe;
- To perform app-related services; or
- To assist us in analyzing the app's usage.

We want to inform users of the app that these third parties have access to your information. The reason is to perform the tasks assigned to them on the app's behalf. However, they are obligated not to disclose or use the information for any other purpose.

Security

We value your trust in providing the app your personal information; therefore, the app strives to use commercially acceptable means of protecting it. But remember that no method of transmission over the internet or method of electronic storage is 100% secure and reliable, and the app cannot guarantee its absolute security.
